   A). Employee wages and vehicle maintenance account for the majority of the increases to the FY2023 expenditures. It
   was recommended that the board approve the proposed FY2023 Budget Amendment.

### 13. Fire Chiefs Report

Deputy Chief Williams provided the following updates.

Truck 42 is in the process of being repaired. A few new repairs have been found, a piston rocker needs to be replaced and two seized fuel injectors. NDFD is hopeful to have the truck back before the Fourth of July.

NDFD is preparing for the Fourth of July celebrations, parades, and fireworks. Chief Hadley, Youngberg, and Captain King are working hard to ensure coverage and strive to create a unified command. NDFD ordered large marking flags for each park that will be used for designated response meeting locations.

Testing for full-time firefighters and a full-time Deputy Fire Marshal In early August, the testing process for full-time firefighters and a full-time Deputy Fire Inspector will be held.

Recently, First Responders First provided a mental wellness presentation for NDFD firefighters, their significant others, and board members. The training was well received and a benefit to all that attended. Board Member Judd stated that the mental wellness presentation was amazing, and enlightening, and could save relationships and help those in need. Board Member Phipps agreed and stated that it helped him to understand what first responders and their families encounter.

Projects finishing up within the district include Lotus and Living Spaces. Openings should happen within the next few weeks.

Chief Becraft stated that Truck 41 has been sold to Evans County, Georgia, for \$35,000. Pickup should occur within the next few weeks.

#### 14. Member City Updates

Board Member Shepherd stated that Clearfield Station Phase 1 is complete, and Phase 2 will soon start. Clearfield City will hold "Cops and Cars" at Fisher Park from 10 am to 2 pm in the coming weeks.

Board Member Vincent stated that West Point City is reviewing and redoing the West Point City General Plan and the residential survey and sewer plan for the unincorporated project. Holiday Oil recently opened, and they have been busy.

Board Member Smalling stated that due to space constraints, Sunset City will have a laser show instead of traditional fireworks.

Chief Becraft provided the board with an update on the construction of Station 42.

Chair N. Peterson stated that in July, the NDFD Board of Trustees will be given a tour of Station 42 and the construction site. The regular board meeting may be relocated and held at Clearfield City Hall immediately following the tour. It was then stated that a videographer will assemble an informational video for NDFD, items to be included are the cities that make up the district, and history.
